#### 1. Who we are

### 4. Who we share your data with

We will not sell or provide your information to third parties other than to information processors with whom we have entered into contracts which require the information processors to comply in all respects with the requirements of this Privacy Policy and all legal requirements relating to information privacy. We share data to the following types of companies (not limited to);

- Referencing and deposit protection services (e.g. DPS)
- HMRC or regulatory bodies where legally required
- Trusted AML verification service providers







- Third-party software providers, such as CRM systems, used to manage customer relationships, communications, and tenancy records
- IT and website service providers for secure data storage and communication
